



The CPD year for all agents runs from 1 July to 30 June of the following year, aligning with the financial year. Agents may complete their CPD training at any time within this period, irrespective of their licence renewal date. Please note that licenses must still be renewed when due.

Compulsory CPD Topics

Class 1 and Class 2 agents are required to complete compulsory topics relevant to their licence class and area of practice. Both factors will determine how many hours and topics are required for each agent.

These topics must be delivered by an approved provider. **Unique Training Providers have been approved to deliver these topics** and can be delivered in a face-to-face classroom session or interactive online session (Zoom). We can also deliver this course in your agency for all staff. Please contact us for more information.

All topics include assessment tasks to be completed within the course timeframe. Assessment outcomes are determined by NSW Fair Trading.

Successful completions are reported to NSW Fair Trading at the end of the CPD year.

This course can no longer be completed by distance learning

Residential Tenancy Law Reforms (3 hours - \$200)

Residential salespeople, buyers agents and property managers who hold a real estate or dual agents licence are required to complete an additional 3-hour face to face classroom session based on the latest residential tenancy law reforms. **Unique Training Providers have been approved to deliver this course.**

Short-term property managers are not required to complete this course.

This course is not available through an interactive webinar (Zoom). Attendance is compulsory to comply with the 2025-26 CPD obligations.

Class 1 Agents Additional Requirement

All class 1 agents are also required to spend a minimum of five hours attending a NSW Fair Trading- accredited event. More information will be provided by NSW Fair Trading soon.

Mandatory Course for Strata Agents

All Strata Agents are required to complete the mandatory commissions, disclosures and fiduciary duty course developed by NSW Fair Trading and delivered through TAFE. More information will be provided when the course is available for enrolment.
